2. We certify the above zinc products (including all grades of each product) do not contain any PAH's (polycyclic aromatic hydrocarbons), any hazardous chemical substances (DOP ,DEHP). Our products do contain <0.15% Lead (EC No. 231-100-4, CAS No. 7439-92-1) which is a known impurity. Lead is listed on the EU Candidate list (SVHC, Substances of Very High Concern) for REACH authorization (<https://echa.europa.eu/web/guest/candidate-list-table> as of ECHA's last update 16 July 2019). All test results of our registered products were submitted by the Zinc Consortium to ECHA and have been accepted and acknowledged by that regulatory body.
3. The EU candidate List is regularly updated for new substances. US Zinc is aware of these updates and is taking care of product compliance. Please be ensured that US Zinc is not intentionally using any SVHC during the manufacturing process of our products neither as base material including the raw materials, nor in the form of additives.
4. All of our product lines are registered at the highest tonnage range for importation into the EU.
